- The annual Work Comp insurance payroll audit with SFM was completed.

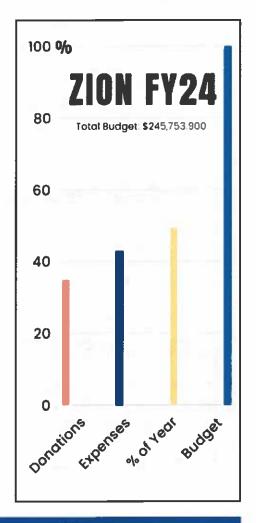

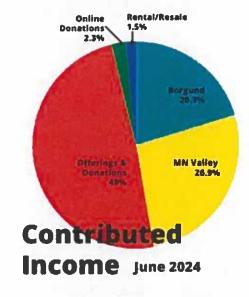

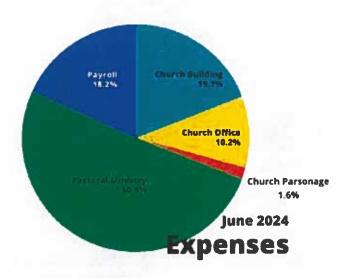
